THE SERVICES ARE OWNED AND CONTROLLED BY SALEASSIST INNOV8 PVT LTD.

THESE TERMS OF USE ("TERMS") SHALL GOVERN YOUR USE OF OUR SERVICES.

THE TERMS "SALEASSIST INNOV8", "WE", "US", "OUR" USED IN THESE TERMS SHALL MEAN SALEASSIST INNOV8 PVT. LTD.

By accessing and using our Services, you accept, without limitation or qualification, the Terms specified herein.
